Item 6: The Board to consider an extension of time for Dr. Michael Lee Gerber, MD, HMD to re-establish his allopathic license. Under the terms of the settlement for Dr. Gerber's administrative action in 2017, he was given until the end of June 2018 to re-establish his allopathic license to then allow for the full reestablishment of his Nevada homeopathic medical licensure under the tenants of NRS 630A. Per the correspondence by Dr. Gerber's attorney, Jeffrey Dickerson dated June 14, 2018 (See Exhibit A), it is expressed that the Medical Board of California had concluded a review of Dr. Gerber's case and his application to reactivate his licensure in California and was now forwarding this case to the California Attorney General to get a hearing scheduled to decide on this action. Dr. Gerber et al are requesting an extension of the deadline from June 30, 2018 to December 31, 2018. Dr. Gerber and/or his attorney will address our Board as needed to clarify any questions our Board may have on these matters and our Board will then decide to grant or refuse the extension. **(Discussion/Possible Action)**

<u>Item 7:</u> The Ad-Hoc Committee to Address the Legislative Council Bureau's Subcommittee on Sunsetting of Boards Report. The Board's Ad-Hoc committee will give a report regarding recent developments including *the decision to recommend the sunsetting the Nevada State Board of Homeopathic Medical* **Examiners to the Nevada Legislature** and proposed measures to counter this recommendation at the legislature. The report by our committee will include commentary by our lobbyist Mendy Elliott of Capital Partners. **(Discussion/Possible Action)**
