Um, so I mean, obviously, wanting to be licensed, and then you know, treating more, I think the big thing with Naisha is course, I never kind of thought cancer was something that I would be interested in. But learning the background of that, and how much cancer is driven metabolically to be able to help those patients and the last study was in 2022, where they were talking about, only 6.8% of Americans are metabolically balanced, that makes almost every single patient like a candidate for this, right, like looking at patients from the metabolic background, to see who's driving, you know, towards that cancer process. So I think, you know, this has been this course, has been a big eye opener, and it just kind of opened my eyes. We're all kind of candidates for that. And I just really want to be a big part of that field.

So I think initially, when I was looking at naturopathic medicine, like as a dietitian, I've worked in many of the hospitals here in the Valley. And for me, I feel like that's a big piece of treatment for patients. And I wasn't getting the response that I wanted from some of the other physicians that I was working with. They didn't want to jump, you know, look at the the nutrition aspect of it. So then when I, you know, started looking at okay, what other you know, what else can I do to, to help treat these patients and learning about naturopathic medicine and then homeopathy, I had the blessing to work under a really great homeopath. I went to southwest College of naturopathic medicine, and I kind of fell in love with it. And, and just that type of medicine. I mean, it's an amazing old medicine and he only treated with homeopathy on his shifts to prove a point that he can literally almost treat, you know, anything he did no other supplements, no other therapies, it was literally just remedies. And that just it just, you know, was so fascinating to me, and he actually ended up retiring. And so I got to work with him on his last ship. So I think that that kind of drove my, my desire for, you know, using homeopathy and more natural medicines and I went to school in Arizona, it's everywhere in Arizona and Nevada. I almost feel like it's not it's not well known enough here. Like, we need more people because people kind of turn their heads when you say, naturopath or you say homeopathy, they're like, Well, what's that? So you know, getting that education, that knowledge out to, you know, our community and, you know, allowing them to have access to that type of medicine, that they have options for doing You know, more natural therapies here?

Just for clarification on the record that protocol language is not under the NRS I believe it's NAC 630 8.1 48, just if anybody needs to reference it. And I'd also like to take a second and apologize to Dr. Edwards and Dr. Fong and the board for not having familiarized myself with the bylaws. From 2012. I was focused on the statute and regs I hadn't even seen them. The bylaws

do dictate that the board is meeting and reserved the 10th edition of Robert's Rules of Order. However, at the same time, I'd also like to suggest that the board create an agenda item for future meeting in which to revisit these now 11 year old bylaws, and consider either foregoing Robert's Rules altogether, or update the language of the bylaws to refer to the latest edition of the rules, as they are currently up to the 12th edition, then might be better served on the new business. But I wanted to get my apology out the Dr. Edwards and Dr Fong out soon as possible so that we can be sure we're all on the same page that Robert's Rules are in effect, even if we're not exactly on the latest addition.

Okay, so from July 1 of 2021 to June 30 2022. The beginning balance of the board was 33,000. Their ending balance was \$41,813. Or expenses for the third quarter calendar of 2021 was 2148. Our fourth quarter expenses were 1481. Now with that said, I don't know if you're all aware of it, but we had some very serious problems that I addressed. When I was up in the Reno office and found out and investigated. We had some attempted embezzlement and by God's grace, I was able to mute that bezel MIT to the tune of somewhere between 10 and \$15,000. So we in cyberspace, if you will, they have this thing called pinging. And pinging is such that, they'll put money into your account, they'll put two cents, five cents, 10 cents, 20 cents, over the course of three or four months, they might put \$5 in your account. Well, at that point it with it, the computer thinks that they can draw money out if the account hasn't been specified. So they started embezzling money out of your account. We had someone tried to get 8900. And there was several other attempts to get several \$1,000. Fortunately, oddly enough, I thought it was on my account when the bank called me and said this was occurring. And I immediately reversed those attempts. And we caught it in time it had gone a few if I hadn't had the bank notify me that I thought they were notifying me on me account, they were notified me on the boards account, which I had set that up as well. So with that notification, I was able to stop it and Sean and myself felt it best that we in the bank recommendations, close the account and open a new account. So when I was up in Reno, Sean and I reopened the account, they put the money back in the account. So we were reimbursed. So that's what happened in November of 2021. Going forward here from current fiscal year in 2023, our expenses have run about \$5,200, they've been very low, as far as you know, rents and things of that nature. current balance is \$50,309 in the bank. Okay, so that's the report. That's the financial report. The next report is the board membership. I will split this out because this is how it's presented on the web. So we have 14 Doctors HMDs of those two are licensed under 630. A, we have eight doctors licensed under 630, a 630, and 633. We have three doctors licensed under out of state. So we have a total of

14 doctors. As far as advanced practitioners of homeopathy, of course, we've taken some on the board, I'm not counting them today. But we have 20 APHS. We have eight H A's. So we have a total of 42 members as it stands right now. So that's that. Okay, so the next thing at hand here, let me get my thought processes going here. So I'm going to talk a little bit about the things that I've done. And this is a kind of a time consuming. issue is the Board website, I'm going to just outline some of the additions that we've made on the board for the last 18 months. So the Board website, it was very difficult to get all the information I needed to get control of the website. But I was able over the course of about six, seven months to be able to achieve that by just keep going after it. Now, a lot of these things you people won't understand because it's computer talk, if you will. So I was able to get access and full security control of our website that is in place. So we have an active functioning website. I was I was able to complete two, I was able to completely access GoDaddy panel, which is our account for our DNS records achieve full access to the website back end administrative panel, I updated the current list of all our licensing and certificate holders. I updated the list of the four new applicants at that particular time. I updated the licensing applications and the renewal applications for HA'S, APH is in HMDs.

In fact that none of that stuff had been done for years. So a lot of that information was it was strictly outdated. Just six months ago we updated the complaint had had the president from 15,20 years ago so we've updated all that material is somewhat embarrassed that I didn't catch that earlier. We set up the an email account for the president myself so so we registered a website domain. We updated the contact information so that people can get a hold of us. We our computer hardware and software we updated all that installed it we digital digitized and uploaded all current licensing and certificate holders files to OneDrive. That's the ones we have the other ones are up in the Reno office. I was up I spent two full days in Reno I had bought the board a a scanner and I was able to scan as many records as I could in a two day period to bring them down so that our files On here would be correct. But most of those records up there, we kept the office that often cost me more for a storage place. So I've kept that office up there, especially if one of our members needs to come in the Reno area myself or whatever. If you as well need access to the board, we can certainly get you in there as a place to work, we purchased a computer had to have one to install the new software, monthly computer we had was purchased in the 90s. And it was you just wouldn't receive any information. So I gotta say, a good deal on a computer laptop to perform the required duties. I purchased the scanner, as I mentioned to you, and of course, I was up in the Reno office scanning scanning, we still to you know, what I want to do is computerized all those records. And quite frankly, that will take a week to 10 days, we've got 30 plus years of records there. And that information needs to be retained in an original retained up into the up into the clouds. So so that's going to be a lot of work, we will we will I will have to hire somebody to help me do that. But I want to do it when the boards are capable when we have more memberships, you know, our board is dead last of boards. As far as revenues, we look at the other medical boards, they're in the three to \$5 million range. So we got a lot of work ahead of us to get people on this board. And I think in current times with people wanting to be in health instead of sickness, I think we can do that and grow the board. Ongoing long term website performance, we want to improve that update as needed. The structure and function of the Application we've made just in the last year and a half, WordPress comes out every every six weeks, a new programs and additional programs and applications that we're uploading, I had to purchase this application. So we could go into the closed session and come out of the closed session. So I'm trying to bring the board into the 21st century, if you will. And so we've done that. And that's that's achieved. So next I want to

talk about I have hired a gal to build our first essentially, homepage, if you will, our design is old, I contracted with Fong design, we've given her a retainer to help us redo some of the website, everything that I can do personally for my staff and get stuff done to save this board money because obviously money is a big issue. I'm doing it in a we haven't had to pay a executive director because we don't have one, we don't have a vice president or two board members short. You all know this. But these are some of the things that we're doing just to try to save this board money. Then now we're going to move on to
