So so we are allowed to as far as our governor to bring on qualified individuals with very intensity backgrounds, and reciprocity.

After that, I took up one year Postgraduate Diploma in forensic sciences, out of curiosity to learn more about medical jurisprudence, and as well as the toxicology, and how it is bridged with homeopathy. Because when I was in my second year of medical school, I had, like, I was inclined towards the toxicology and homeopathy can work in that. So I got the opportunity to understand that field. And in the meantime, I was also working with different organizations, specifically targeting the cancer. And we were actually practicing homeopathy to the patient, those who are coming with a high risk of cancer as well. And after my all, it more than six to seven years of experience, under many doctors, by myself, and I used to run two Classical Homeopathy clinics, which, where I continued to provide my Compassionate treatment to all my clients. And but I was a little bit unsatisfied with myself, because I wanted to move out from my four walls to work for the community because I feel very close intent when, when I was doing that, because I want to reach out to everyone, and specifically, educating them about the homeopathy and its efficacy. So I decided to move out from my comfort zone from India, and came here to continue my education by doing a master's in public health from University of New Haven, which eventually opened my door to work for the government, public health department where I worked as a public health educator to promote education, and as well as community health. So that really helped me to open my mind to work with different public health champions, different public health advocates. And there I learned about how the society work, how community are thriving for a proper health care system. And then eventually, I got an opportunity to continue my education and continue my work

experience as a homeopath with American Medical College of homeopathy, where I am right now teaching as my, my major subject, which is Materia Medica, homeopathic Materia Medica. And immediately, they also offered me to teach a homeopathic repertory because that is my minor. So I didn't major in homeopathic Materia Medica, and minor in homeopathic repertory. So and also, I have more than seven years of experience as a clinical experience. So they also give me the experience clinical classes for their students. So which actually helping me to stay connected with homeopathy and also helping me to promote homeopathy, wherever I go, because I have engagement, half of life in homeopathy. And I will also want to share, I'm sorry, I'm taking a lot of time, but I want to share why I'm why I was inclined to homeopathy. Because I've been raised and grown in the atmosphere of homeopathy, my my mother's side, everybody takes homeopathy, medicines for the, for their optimal health, for complete wellness. And I also had an experience my personal experience, which actually helped me to get inclined toward homeopathy. With my father. My father was admitted it was two in 2008. I was in my school, medical school, I was very young to the medical, homeopathic medicine, because I was learning. So my dad got sick, he, then all of a sudden he fainted. And they took it. My dad, they took it to the ICU. So but before that my dad was suffering from high grade fever. So I, I went to my professor and asked him, What should I give, I gave all the symptoms, everything to my professor, they recommended Jessemiam 20. So I gave it to my dad. So within like two days my dad puked and that's why my mom took my dad to the hospital. And later on the doctor actually told my mom, it is a good sign that your husband puked otherwise he went into him, I went into the diabetic coma. And I think it because of Gemsimuim 30 and Pharaoh four and 6x vitual actually helped him to prevent went into diabetic coma. So that was a highlight of me to understand the beauty and efficacy of homeopathy. And currently I'm in Nevada, because my husband is in Air Force. And he used to live here in Las Vegas for six years. And I think, and I firmly believe the the success is because only three states has the license for homeopathy. And I feel the future of homeopathy is very bright in Las Vegas and in particularly Nevada State. And I would be honored if I get a chance to showcase my experience and I will be able to provide my services to the community. So this is how my life turned from a small little girl who just entered the homeopathy school, and now has been in this field for so long. And I'm still trying to learn more and more and more.

## Bruce Fong DO HMD 39:35

Thank you, Dr. Dhaani. Again, I asked you this earlier, but I'd like to qualify this again. So you've had over 20 years of experience specifically in homeopathy, and also have four years experience. Okay. Okay, since you have more than 10 years of experience in that. So again, the governor's Edik when you guys read it, it's a little vague. It's just saying that they have not knowledge of the this type of medicine, in this case the type medicine, to me a reciprocity has to very specifically be in homeopathic integrative or alternative medicine. In my opinion, Dr. Dhanni actually does qualify, I would love to see my one of my best friends, Dr. Zinni, I can just bring him in on that. But Phil's more than happy to take the test. But again, it has to do with the fact that, you know, Phil, he already told you he is he's just more recently got on board with homeopathy. And He's raising his Android phone.

#### Phillp Zinni DO 40:33

So I'm a little bit more about my background. I'm also the past president of the American Osteopathic Academy of Sports Medicine, and the subject of education and training and fellowship, always came up. So Bruce is spot on. Because if if you set a precedent, then people

are going to challenge the board. So you have to be tight with your criteria. So that this way, if someone tries to challenge the board, then you guys will have a precedent that excuse me, a precedent that can not only stand, but something that you could defend in the public court of law. So what Bruce is saying is, is really spot on. The only thing that I don't know, is the year qualification. And again, that's a big nebulous ring and 10 years, if you think about any type of licensing, that's a long time. So I think 10 years, I think would be a good bar to have.

## Bruce Fong DO HMD 41:50

Yeah, I fell, I really appreciate those comments, I believe that it used to be that you had to be at least 10 years before you could apply to be a nurse practitioner from being an RN. So that's kind of one precedent we can look at as a decade. So again, board members, if we appropriate tonight, through this reciprocity, we can say that the precedent we're setting is 10 years right now, we can always change that later, but the minimum is going to be 10 years, or we can actually lower it or are elevated, but we're saying it's 10 years right now, if that's

### Dr. Greg Olson 42:22

Let me chime in for just a second, I think 10 years is great. But it's also 10 years, specifically in homeopathy. And she's credential internationally, in India, as a doctor of homeopathy. So it's, it's not like she took a weekend course in Albuquerque, and she wants to become an APH, ah, she has the academic background, she has the 10 years of experience, and saving your dad is always a really good plus, you know, somebody you can take it in an acute, you know, chronic situation, where someone's about to go into diabetic coma and can use a homeopathic remedy to pull them out. I think that's what we want. We want someone who's able to go there and, and really use homeopathy for what its intended, which is its own separate type of medicine. And we want people like Dr. Dhanni, and I might, from what I'm hearing here, you know, I'd love to have 10 more of her coming in just like, you know, with the same experience,

B Bruce Fong DO HMD 43:28 I agree.

### Frank Shallenberger MD HMD 43:32

You know, make the comment that it's not so much how long you've been doing it. It's what, what your training is. And for example, if you've just, if you're if your training has been even if you've been doing it for 30 years, your training has been in traditional pharma medicine, you know, that, you know, that doesn't qualify you. On the other hand, if you've graduated from a naturopathic school, or as this applicant is done, if you graduated in a program that deals with this, I think that meets the criteria. I don't know that we need to, at some point, we can discuss this, of course, but I don't need to I don't know that we need to say 10 years, five years, two years, one year. I think, you know, if if we can, if you have if you have a degree, okay, if you have a degree that encompasses the kinds of things that we do in in our, in our homeopathic medical that should be ultimately the criteria.

Bruce Fong DO HMD 44:49

So today, I'm gonna play devil's advocate a little bit. So we have other applicants who have lesser time with have the same kind of training. We've traditionally asked them to take a test. I guess the question before us is where do we not ask a person to take the test? So I think that the year, the years of experience in that specific field may very well be that criteria we're looking for. So it seems like we're putting a decade as sort of our artificial ceiling right now.

Dr. Greg Olson 45:16

But you're also talking about reciprocity versus somebody who is trained here in the United States, you know, is this reciprocity is can we attract people internationally? Who would want to come here and help expand homeopathy? She has reciprocity because she has diplomas, and she has clinical experience. And it's been 10 years, that's a plus. But if somebody was trained at a naturopathic school, and they they did a year internship somewhere, and they've been practicing, are we going to say, yeah, you've got to come take the test, as an APA chair as an HMD. Is it just for international graduates that there's reciprocity?

Bruce Fong DO HMD 45:57

Reciprocity is supposed to be across the board, but you actually bring a point. Now for an HMD that Dr. Dhaani, if you actually had your MD here in the United States, you actually could apply for an HMD the problem was my thought too. So the way that 630 Nevada Revised Statutes 630 A reads is that a homeopathic medical doctor has to be either an MD or DO who graduated from a school accredited school here in the United States or one of the US territories in Mr. Feeley? Please forgive me, I am paraphrasing. So I'm not quoting the exact thing. But the bottom line is that I personally think you're eminently qualified to be in APH. I guess the question before the board again, is where do we draw the line of saying, I'm gonna allow this person to come in without having to take the test? That's the question before us tonight. And again, I hate to belabor this point, but again, we're charting new territory as of the speed doctors any good. Give me any comments you have.

Phillp Zinni DO 46:56

So I can also give you a previous precedent that the American Osteopathic Academy of Sports Medicine had, and that was, in the beginning, before they had a board certification process. They would grandfather people into fellowship with experience, and the experience had to be 10 years. So I don't know what makes 10 years magical or not magical. I have no idea. But there is precedent for that 10 year mark.

Bruce Fong DO HMD 47:32

So I agree. So for whatever reason, I agree with Dr. Zinni. All the years I've been in advocacy groups, legislative advocacy, etc. We've I've noticed a 10 year seems to be some kind of magic number for across the board for every type of healing art that the 10 year mark seems to be

where a lot of people change the rules so to speak.

Dr. Greg Olson 47:56

Well, can't we take it on a case by case basis as someone who feels like, hey, they've got eight years of experience, and they can show similar training similar credit, then as a board, we can decide, yeah, maybe you don't need the exam, either. Because you've got, you know, the experience that we feel that you need to have, our job is to protect the public. And if someone can convince us that they're capable of doing the job, that's what we're saying, okay, public, we're saying this person is qualified to come see you. And 10 years is a great number. You know, if we make it too high, then all of a sudden we're winnowing out the field of who can come in and work in Nevada.

Bruce Fong DO HMD 48:32

Well, I mean, at that point, they stopped testing. So come in. That's that's all

- Dr. Greg Olson 48:36 it's still take the test. Right. So
- B Bruce Fong DO HMD 48:39 and then Darko said he had another comment.

Yeah so the the issue respectfully, is when you do things case by case, that's when you No, refer or defer to Mr. Feeley. This is his bailiwick. But I would assume that as soon as you have a moving target, that's what makes your board open to challenges and open to lawsuits. Because one person got in for eight, another person got in for seven, another person got in for nine, because it was a case by case.

Ultimately, we'll have to establish some criteria. I don't know that we're going to do that tonight. But we can work on that. Yeah,

Bruce Fong DO HMD 49:20

I agree. I think that initially, this case by case thing, we have no choice but to do it that way. But I think that sort of a precedence being set is we're seeing about 10 years right now. And now again, that's open to interpretation. I agree with Dr. Olson to say that we have somebody who's more eminently qualified, the board can make that decision. The bottom line is that we don't have and I agree with Dr. Tom or we don't have to set anything in stone tonight. But the fact is that we all should remember how we're thinking about what our thought processes tonight and how we're going to vote. So any further discussion, just

The quality of our practices are now currently mixed up pure homeopathy is something that has been seen, not rarely. And we have been mixing conventional, integrative alternative medicine, the qualities of Dr. Dhaani is very unique. And to bring this purity back into the board, it's something that we definitely need. So, again, I agree, this is something that we have think about, but pushing for her case for her credentials. This is something that again, that would probably hopefully trickle down, our board and practice group will be off with you again, integrated more a little bit more with our practices.

And normally, I wouldn't call the question by now but this is a like I said, Well, I want everybody to be able to say their piece tonight. Mr. Feeley? Do you have any comments for us or anything you think might be helpful?

But no, I don't think so. I think it shows a lot that you there's been a lot of discussion, thoughtful discussion going back and forth on this. Again, I still, I haven't seen this edict Personally, myself. So I guess I can't speak too much on the specifics of how it's going to go. But so far, everything seems an order to me,

let me Let me chime in a little bit on that. Because all of that really fell into my desk and my opportunities. So I had to look at 003 and 004. Very, very closely. In fact, we were we were on the line to be sunsetted, according to requirements that the governor had put out. So so I put a 30 page document together saying homeopathic, homeopathy needs this place in the sun. And obviously, we're still here. But the reciprocity issue, is a golden calf for the governor. And that he's, he's he wants Nevada to be a leader in bringing opportunity to the state. And I really applaud him for that. He said that right out of the gate. And so maybe everybody didn't agree with him on that. But But we're here to, he wants to have boards be more open and friendly. Certainly we're regulating a body is certainly all that's important, especially in medicine. But he wants it across the board and professional trades, that leads people into the state to certainly have the qualifications. And I applaud him for that. And I don't think we're going to see a lot of pushback on this. And this woman didn't didn't ask us to do this, she was more than willing to

take the test. But when you've got somebody that's qualified, I want to set a precedent here. Because we want more people like that, that made it their life's challenge, especially in homeopathy. So I applaud this woman in her work in her effort.

Any opposed? Dr. Dhanni, congratulations. You're our First Person we've ever done this for and I welcome you to our community warmly. You get applauded, guys go. Alright, moving on. Agenda Item number eight, discuss recently approved submitted. Senate Bill 336 to the Nevada State Legislature. Mr. Green, you have much more expertise than I do on that. Please take

this. Yes, yes. And I'm so excited to bring this up again, that we certainly brought it up at the last set of board members. I thought it was important enough to bring it up again tonight. I don't know what you guys know or don't know. But Dr. Royal had written up SB 336. He took it to the Legislative Council Bureau, they made an official amendment. They redrafted it, they accepted it. Dan and myself, went up and testified in front of the Senate and the legislature and for prosecutorial issue on one of our physicians. And that he was using a protocol called IPT. And I'm sure all of you are well aware of IPT. So I don't have to belabor that. But the short of it was they were prosecuting for that. It's it's a it's a modality has been used since 1930. I thought it appropriate that we speak up on that and say that he is a dual licensed physician. So he had the authority to use that, as in his protocol sets. And we got the bill sponsored by Senator James Ochrenschall, Inner Inner committee meetings up are our meetings up there, we were able to get a second from Dr. Stone, or excuse me, Senator Stone, and he co sponsored the bill. And then they had the vote and it was unanimous through the legislate Senate, it was unanimous to the legislature and it became law when the governor signed it about two months ago. So now, the essentially the bottom line is the DO board has to play in their sandbox. And if they get a complaint against one of our physicians, using alternative medicine, they have to they have to turn that over to us. Dr. Fuller, who has just recently passed away was he was at he in 1999 was able to get medical doctors similar type of action in that. Essentially, the medical board is supposed to turn over any complaint to us on those types of procedures. So So dual licensing is means something now for both medical doctors and for DO. And so I'm proud to say that SB 336, the governor signed it, it's law, and they have to abide by it. So we were able to achieve that just this summer. Now our legislature doesn't meet until two years talk that I've been around for the two years I've been involved with this board is to get Natureopaths board. They were licensed in 1986. For whatever reason, the setup didn't like the way they were operating their board, the board was closed sunsetted and this is obviously 30 40 years ago. We've talked to the naturopathic board, they're now in 26 states, they wrapping their arms around us to bring legislature into the Legislative Council. The next time they meet to try to get naturopathic license in the state of Nevada. I would also like to talk to you folks and as far as others and I'd like to see if you've got a doctorate in homeopathy. I don't think you need to work under another medical doctor. So I'd like to see serious homeopathic doctors be able to have separate licensing as well. So I'd like to see our boards, licensed DOs, MDS Natureopaths and clinical homeopathic doctors. So if I think that's something that we can work on over the next two years until the legislature meets, and write up some legislative information for that. So I just want to apprise you of what we're able to do. We do have a wise

constituent was Dr. Royal, you know, his father, obviously, with logic folks understand this board, if you've been involved with for four decades, but he brought it about, Dan was very eloquent the way he brought that together. And we went up there and defended homeopathy, you know, my background, you may some of you may know or may not I, we developed the homeopathic product for allergies. And I went from zero to 100,000 bottles, and hence why I got essentially nominated for the board. And then it was my background, I'm a degree in in accounting, took on the position of the secretary treasurer. And I worked hard to straighten out this board as much as I could, based on what I was given. And it was pretty tough battle. But I had the legislative body now satisfied with our accounting, and I got zero accounting from anybody, the past secretary treasurer of the board, so I had to reconstruct all the books, and I put it all into a platform that the LCB now accepts. So our books are now organized and up. And that took me guite a while.

#### Bruce Fong DO HMD 1:01:47

I'm assuming you're we're done with the discussion about the bill and Senate Bill. And number one, I applaud you, Dan roll and everybody else is involved. You've given the board Teeth that we can use in the future. And I want to let everybody know that it sounds like we're now in agenda item 10, for the compensation of Mr. Green for the work he's done. So Charles, please continue.

Okay, so most of you know me, I really take this job seriously. And I've done a lot for the board, in that. It's a 40 year old board. Websites weren't even around back then. So the website is old school, it needs redone. And one of our agenda items I'm looking at is a is a program from FreshWorks to as a networking application for us. So what I'm looking to do, and quite capable of doing is modernizing our board. So and I want the board to be a a shining or the website to be places US physicians can go and get good information on on Homeopathics. So I'm looking to put it you know, and that's what Dr. Glavinovich and myself are working on. With the start of the integrative Medical Foundation, we you guys need information you need you need to make good medical decisions, you need information. And we want to create a with the integrative board a phenomenal library, to all physicians to have access to. So you know, that's something that him and I are working really hard on. We have access, we hope to some funds in Washington, we were we want to bring a some serious money in coffers, to our coffers here so that we can defend this board. This board is in the debts, are inexcess of the revenues. And so we need membership. So far we've been able to bring on, we've had a few people leave with a few more people. And we want to continue that but we can't get by on 50 Members, we have to double or even triple that. And I think we can do it with naturopaths. And I think we can do it with Classical Homeopathy. This board is natural medicine, and we are the voice for natural medicine not just for Nevada. For across the country. My goal would be make this board a poster child for that very avenue that people use natural medicines. You know, I've been in the nutritional industry 50 years. And these products work. I've sold them pretty much my entire life. They're they're better than some of the best drugs out there. And they have no associated side effects. Why doesn't Medicaid and Medicare with a solid research we have accepted? And we all know the reason why the drug companies have a thumb on everything we do. I think we can we can rectify that. I'm a member of the National Products Association. There is another association that you guys may or may not be familiar with called the the citizens for

homeopathic choice. A gal named Paula brown founded that organization about five years ago. She's got she's got 1000s of mothers is blowing up the inboxes in Washington DC, on senators on homeopathy. So she's out there single handedly educating a lot of these folks on homeopathy. Now, if you're if you go to the National Institutes of Health, they criticize homeopathics, you go to the FDA, they criticize Homeopathics. And the things that we do, you know, I wouldn't sell 100,000 bottles, your product didn't work.

Sorry, but we got to stay on topic. This is kind of drifting a little bit off topic.

Charles Green

I just obviously, you're seeing my passion. And what else I've tried to accomplish with the board. The problem is funds, we do not have enough funds. So we're looking to bring in more funds. But meantime, I've got to have you know, I've got to have some money to have to work the board and the things that I've done, I can't keep funding the board. So I'm looking for you to Okay, the second to the last meeting, they okay to three months stent for me and I and we put it off for the last five months, six months now. And so I'm do from July to December, in the like the board board's approval on that so that I can continue on with my work.

Alright, so historically, you know, historically, I, personally, I've got \$45,000 into the board on and that's mostly an employment for my staff. But I don't do that anymore. I've been working on the board. So the fee that I'm paying myself is what's allowed through the NRS, which is \$2,500 a month. So the board would owe me from July, they paid me three months. And then they wrote me from July to December, because we postpone this till now.

Alright, so that'd be 2500 a month, times, six months, it would be \$15,000.

That's something we need to think about in the future to take the workload off. Charles. Charles, I love you, but you're killing yourself. We don't need that. I would I would point out it's precedent ladies and gentlemen, that we paid an executive director in the past 2000 a month for for the the role that the she would play. Charles kind of actually talked about it, and then he kind of just meld it into this issue. So that's when I interrupted him the first time. The long story short is thanks to his Charles and Dr. Dan Royals work, the the ability of one board to say that, hey, I have jurisdiction over somebody who's duly licensed versus another board has not been quashed, we have precedent, we actually have a law in place that says that. No one board can claim jurisdiction over the other until both have done their jurisprudence. So that

I understand that Bruce. But here's the deal. The medical board completely just thumbs, flips, flips us off on that. They pay no attention to that at all. So I'm going to make a motion that our legal counsel sends a letter to the medical board and informs them that need to obey the law, because I'm sick and tired of these guys acting as though they're king of the world.

I have a motion on the floor regarding the previous agenda item which was regarding that Senate bill that we have our legal counsel, I guess you Mr. Feeley started dropping in this to draft the letter basically asserting our rights. Bruce, I outlined it in you the fees are allowed to go up to \$2,000 for HMDs. Obviously, I think I don't want to lose people by saying a \$2,000 fee. He saw an increase from six to eight I think is more appropriate. And then as we move forward, it'll get on more members, we can talk about lowering the price. But the board needs money to operate, you know, in the money's not there. As the accountant, I will do everything in my power to wash your expenses. You know me I add a couple of things my first hour on the job in the car in Reno, at our office. I was there 15 minutes, and I caught \$15,000 worth of embezzled. From HMDs, from 600, to 800, APH's, from 400 to 600, and Ha's from 200 to 400. And so this is in front of us for consideration and discussion. And a means of generating additional revenue for adequate amounts for the administration of the of the board for proper service of licensing and certificate holders.

Whether you have everybody I know the board raise fees a few years ago, that was also necessary. Again, understand the board has the right under Senate Bill 98 from several legislative sessions ago to raise the fees even higher, we're trying to not overdo it. But we need
