All right, we were able to file 003 This is in reference to the 004 2023 004. This is an order directing all Nevada occupational and professional licensing board to suspend the issuance of any new regulations show cause for all regulations, licensing requirements, and provider a recommended pathway for facilitating licensed rep reciprocity. We've requested an extension of time recommendation to the governor's office. And now we have with Joels' help, we have now set the stage for that document and is near completion and it will be filed by July 1. Wonderful. So that's the status of that 004 At this time. All right,

You're seeing that? It's very good. Perfect. Okay, so the report itself was actually due April 1. And the requested phase outs or plans were to be implemented by July 1. So there is some confusion on that I don't think is the biggest deal right now, especially as there are so many boards that are scrambling, and they're still so overloaded going through 003, that I don't think it'll be an issue. So let's kind of go through it. Section one, they're asking again to identify the regulations regarding licensure. That's for any licensed permit certificate, including applications, examinations, testing fees, continuing education, things like that, along with reciprocity. So I went into your regulations, and starting with NAC 630 A 050, all we have are application for license your examination to practice homeopathic medicine, your medical competency examination, the examination of graduate or foreign medical school. postgraduate training of graduates of medical or osteopathic school or foreign medical school post graduating in homeopathy approving the courses, training and homeopathy, interview of graduate school licensing by reciprocity, which this is the real big one that I'm glad you guys already have. And that'll make your life a lot easier. Continuing Education requirements, temporary and special and limited licensing. And you'll see that some of these are a bit duplicative and can be condensed and or combined. The fees and there's a little bit of tension in that because everybody's the governor on one hand, they say, bring your fees up to date with the actual reality of what you need. And now the other side saying cut fees and got everything that makes getting a license more difficult. So and the last one is notification of change of address, which it's, it can be cleaned up a little bit. So the justifications I'm going to give Kathy and the public and anyone else who hasn't already. Is it big enough? You can actually read it. Yeah. All right. So take a minute let me know what you need me to scroll down. I don't think you actually need me to read it for you. But basically, the idea is health care and people's choice of healthcare is the argument is that is inherent right? How can I have life and liberty and freedom to choose happiness? If I can't choose how I maintain my life and maintain my liberty from hospitals and all the other stuff? And you know, decide how how I'm happy is being treated? It's it's, you know, you know, being privileged at a hospital, all those are reflective of the fact that that person has met some basic medical competency, and is deemed safe to carry a license be involved with the hospital.

So do you want to put in that they have credentials matching national minimum standards are the cause really, how can we have national minimum standards if there's only two states yet?

Well, so it gets kind of complicated. But ultimately, we're saying that yes, somebody say trained in England, who did their residency in Boston, moves her family to Tahoe, and is great interest in doing homeopathy, his Massachusetts state license is what qualifies him. And we want to know that he had good medical training, and if he went to Oxford, or he went to some other school, then we know that those accredited schools would qualify in comparison to the schools that we have here in our training program.

Temporary special licenses. I believe you guys need this for short term coverages and things like that. Limited License is for while you're a physician and you're in training, but not fully licensed. Is that

Fees, we know that we need those because the board needs to operate. And change of address is obviously required to keep most up to date contact information. All right, so that brings us to section three, section three, they're looking for suggestions, to revise or condense or get rid of some of the regulations that might slow impede or stand in the way of licensure. It's a tough balance, because you don't want to just open the floodgates to anybody with a pulse, they still have to, you know, prove that they have the skills and abilities to do what they say they're doing without causing any more damage to the patient than they already have. So, and again, welcoming more suggestions from you guys. You know more about this than I do?

Thank you for joining sorry that you were stuck in the waiting room limbo. We're now on Agenda Item number five of the agenda. We're reviewing the draft report. In response to the Governor's Executive Order Oh, 004 for this year. I explained that although it should have already been a on April 1, there's already been an extension requested. So that should be fine. The initial first section just to bring you up to speed is just a list of regulations regarding licensure, applications, examinations, education fees, and the other associated regulations for becoming a homeopath or homeopathic assistant, or advanced practitioner. Section two is justification for the above why we feel it's needed. Charles, if you could email him a copy of the document for his own records and ease. I kind of did an overview of gross look down and framed it in terms of the Vatican public should have the right to choose homeopathy, just like any other modality of healthcare. And that's essential to our ingrained codified in the Declaration of Independence, rights to life, liberty and pursuit of happiness. So it's a little wave the flag, it's a little wave the Constitution. And I think it fits. So we had got through most of the regulations and a basic justification for each one individually. And we have gotten down to there we go. I think I know, 90 Yes, reciprocity. So again, that's the big thing that the governor wants to ensure that all boards have is to allow people from other jurisdictions and other states and countries to come and practice here more easily. You guys already have it. So it's one big checkmark in your favor good stuff. Moving on to 096, continuing education requirements and exemptions. So they are required to maintain maintain standards and quality and ensure the latest advancements that everybody is brought up to date, when new things are added to the Pharmacopoeia or removed or whatever dosages is established. You guys know better than I do. We talked about temporary and special licenses for substitutions and coverages or if you're working under a supervising a. Ha. No, not Ajay supervising HMD. And if there's the medications on him or her, the fees that we need to keep the board running and make sure they send them an address. Those things are pretty basic. But now we're talking about section three here revising any of those, and I think it would be a good idea to combine and condense the regulations relating to vetting applicants educated in other programs outside of local homeopathic training. So just make a big general Tatchell for medical doctors osteopaths homeopaths from other places, other states, other countries, and if we can combine it into one regulation, I think the governor would appreciate that. We and I discussed this with Charles fees need to be reasonably increased. It's To count, I apologize, I have a four year old banging on my door. So we ought to go away. On top on, the mommy knows a bit of meaning I can't come down to eat now. It's good. Yeah, she's really cute. I can't I it's so hard to be manager. And that's one of the things that were discussing with I was discussing with Charles, the tension between the need to increase fees to account for cost of

living and inflation and all the other expenses that the board has compared to making things easier for advocates. So maybe a more generalized or, you know I don't know, just charge people more. I don't know what to say.

The change of address regulation is long, and very much more than it needs to be. All I need to say is, keep your address updated anything, you know, if you move within six weeks, and we don't know, you can have a violation, boom, it doesn't need to be five paragraphs. But besides that, they're pretty good. The other one I was thinking is, again, a gross, big picture for temporary special limited licenses, that doesn't need to be broken up into two separate regulations with all the subsections, I think. But it's your board, you guys tell me if you like it, if you want to add something, if you have other suggestions.



Charles Green

In reference to reciprocity, the Cato Institute put out a wonderful article on that. And they were saying that, across states boards were stymieing anywhere from 2.7 to 3 million jobs. And the states were collecting and fees, close to \$208 billion. And I think one of the things that upsets the governor is if you're a professional, if you're a doctor, or even a professional Carpenter, trades person, and you're in whatever state and you have 10 15 20 years of occupational professional understanding that that space is via Carpenter, or what they're saying is you shouldn't have to redo it. The problem is, you come into a new state, you've got a whole subnet of board exams to take. And what they're trying to say is, hey, if they've taken those apps in that other state, those those those things should hold up in our state. Now, should we be required to look at other states? Guidelines to see if it is commensurate with our guidelines? So we say yes, Maryland has a nice set of requirements. And since that that professional person, he's the doctor a plumber has has achieved that skill set, and has been at that trade for 15 Plus or whatever years that we should be just do it administratively. Check his background check his is, whether he's as a criminal activity or fingerprints and do all the normal administrative duties that I have to do to vet these folks? I think that's what they're reaching for my when you're talking about reciprocity, is that your lines of thought?

Bruce Fong DO HMD 38:39

Mr. President, if I can make comment, sure. So identify for the record, this is Bruce Fong. Formerly on the board, reciprocity really is referring to specifically a homeopathic license or certificate here. And the only other state, as far as I know, currently in the country that licenses folks like us, is Arizona. So basically, at this point, this only this clause would only apply to Arizona or some other state, should they establish some sort of integrative or homeopathic medicine board. So at this point, I can tell you the Arizona's requirements and ours are almost identical. So so from that point, Charles, what you were saying would be exactly correct. You would be giving somebody who say for instance, wanted to come in from Arizona, to Nevada to be licensed, because we know that their standards are comparable to ours. And we did we did a review probably a little bit over 10 years ago, but maybe that needs to be redone again, but the bottom line is that we know that their standards are essentially the same as ours. So

normally, we would actually provide the license without having to take an exam. Just be primarily just an interview with the board. And you know, just making sure that you think he's a good he or she is a good person then and just go from there.

If you guys can find better sources for me, I would love it. But according to Wikipedia regarding regulation homeopathy, Europe, Austria, Germany, no specific regulations exist, while France and Denmark mandate licenses to diagnose illness or dispense of any product is to treat any illness, someone Repatha treatment is covered by the National Insurance with several European countries, including Denmark, some parts of the UK and Luxembourg. In other countries such as Belgium, France, Czech Republic, it's not covered. In all shares. public insurance requires scientific proof of effectiveness in order to reimburse medical treatments. But exceptions are made for homeopathy. In 2004, Germany, which formally offered homeopathy and its public health insurance scheme withdrew this privilege, with some exceptions. So again, I have to give, you know, the positives and the negatives are good overview. I can't just give cherry pick the good parts. Yeah. In June 2005, the Swift government withdrew insurance coverage. They did not meet an efficacy and cost effectiveness criteria. However, following the result of a referendum, the five therapies were reinstated for further trial. So they didn't like on but they're still studying of not too bad in Canada. We'll just talk real quick about how they do it. And Mexico is currently regulated in South America, a bunch of countries. So basically the army mean is there places that we can pull from that do license homeopaths that we can give reciprocity from aside from just Arizona. And that might be that might hit the goal of bringing people to the state and we're relaxing or making it easy to get a license. So again, I said, it's a

goal of the board's recruiting homeopathic medical professionals from Arizona, as well as those states that don't regulate the practice, as well as the Americas, Europe and Asia. So I'm open to suggestions of rare revision change, addition, whatever you guys like. What do you think?
